DESIGNATION OF DIVISION HRMPSB SUB-COMMITTEE FOR THE ASSESSMENT OF TEACHER II AND III POSITIONS IN ELEMENTARY DISTRICT AND SECODARY SCHOOL LEVELS

- 1. The Department of Education have issued the Merit Selection Plan through DepEd Order No. 19,s.2022 which establishes a competency-based selection and placement of DepEd employees.
- 2. Item 82 of aforementioned DepEd Order provides for functions and responsibilities of the Appointing Authority which includes among others the designation of sub-committee/s:

Item 82.b of DepEd Order 19,s.203:

Designate sub-committee/s, insofar as practicable, to assist in the receipt of applications, initial evaluation, and comparative assessment of applicants. This shall be done in close coordination with the HRMO and HRMPSB. The designation shall bear the specific duties and responsibilities to be performed by the sub-committee/s.

 - b. Make a systematic assessment of the qualifications and competence of applicants for appointment to the vacant Teacher II and III positions;
 - c. Submit to the Division HRMPSB the result of the comparative assessment and the Minutes of the Deliberation;

- d. Maintain fairness and impartiality in the assessment of applicants;
- e. Respond to queries and/or complaints pertaining to the comparative assessment in the school level;
- f. Perform other related functions as may be assigned.
- 5. The HRMPSB Sub-Committee shall conduct comparative assessment in the school level in close coordination with the Division HRMPSB and HRMO. No assessment shall be conducted without the memorandum coming from the appointing authority.
- 6. The result of the assessment conducted by the Sub-Committee shall be reviewed and deliberated on by the Division HRMPSB and shall submit to the appointing authority the CAR/CAR-RQA, highlighting top five (5) ranking candidates or less, and the Minutes of Deliberation.
- 7. It is hereby directed that the names of the HRMPSB Sub-Committee per District and Secondary Implementing Units be submitted to the Office of the Schools Division Superintendent for evaluation and approval not later than December 15, 2023.
- 8. For information, guidance, and strict compliance.
