**CONDUCT OF PRESENTATION PORTFOLIO ASSESSMENT FOR ALTERNATIVE LEARNING SYSTEM ACCREDITATION AND EQUIVALENCY ELEMENTARY AND JUNIOR HIGH SCHOOL LEARNERS FOR SY 2023-2024**

1. Parallel to DepEd Memorandum DM-CT-2024-025 issued by the Office of the Curriculum and Teaching (CI) strand dated January 23, 2024 entitled "Reiteration of Deped Memorandum No. 22, S. 2023 as Basis for the Conduct of Presentation Portfolio Assessment for Alternative Learning System Accreditation And Equivalency Elementary And Junior High School Learners for SY 2023-2024", this office will conduct a Presentation Portfolio Assessment (PPA) on February to May 2024 in the identified Community Learning Centers in SDO Sorsogon.
2. The following are eligible to submit their Presentation Portfolio for assessment:
  - a. A learner enrolled in the Learner Information System (LIS) for SY 2023 who has satisfactorily met the set of competencies in the learning level of A&E Program as agreed with the ALS Teacher/Community ALS Implementor/Learning Facilitator.
  - b. Previous ALS Program Completer not registered in the LIS of the current school year who submitted but did not meet the minimum required points in the two previous Presentation Portfolio Assessment BUT underwent additional learning intervention in the ALS K to 12 Basic Education Curriculum (BEC) certified by the ALS Teacher/Community ALS Implementor/Learning Facilitator.
  - c. Previous ALS Program Completer not registered in the LIS of the current school year who did not submit presentation portfolio but underwent appropriate learning intervention in the ALS K to 12 Basic Education Curriculum (BEC) and with duly updated all the formal records certified by the ALS Teacher/Community ALS Implementor/Learning Facilitator.

- An ALS learner who shall undergo the process of PPA shall be **at least 12 years old for Elementary Level (EL) and at least 16 years old for Junior High School Level on or before May 15, 2024**. Only those who met the minimum required points and passed the PPA are eligible to receive the EL or JHS Certificate.
- All ALS Learners who shall undergo the PPA process **must be duly certified to have completed** the corresponding program learning intervention.
- The Division ALS Focal Persons shall conduct an orientation with concerned personnel who shall be involved in the actual conduct and monitoring of the PPA. The modality for the conduct of the said activity shall depend on the quarantine protocol level set by the Inter-Agency Task Force (IATF) as well as the most recent DepEd rules and/or policies. They shall also monitor the actual conduct of the final validation.
- The step-by-step process of the Portfolio Assessment is contained in paragraphs 13-49 of DepEd Memorandum No. 22, s. 2023 and the DM-CT-2024-025 for your reference.
- Meanwhile, the table below specifies the schedule of Phase 1 to 4 of Presentation Portfolio Assessment for SY 2023-2024. **Special Committee on Education Assessment (SCEA)** will be created for every school/district who will evaluate the learners presentation portfolio. **The CLC/School/District shall come up with the mechanism, schedule, and modality of Initial Assessment and District Validation.** In case the personnel involved in the PPA completed each phase ahead of the given schedule or time frame, they may proceed to the next phase of the process.
