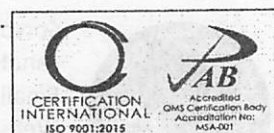
1. In line with this year's celebration of the National Teachers' Month and World Teachers' Day, this Division will conduct the following activities as stated below on specific date and schedule, to wit:
