DepEd, Schools Division of Sorsogon (Province), through the Division Bids and Awards Committee (Basic Education Facilities Fund – Rehabilitation, Renovation, Repair of School Building and Water and Sanitation Facilities) intends to apply the sum of Six Million Eight Hundred Forty One Thousand Six Hundred Seventy Four Pesos and Eight Four Centavos (Php 6,841,674.84) being the Approved Budget for the Contract (ABC) to payments under the contract. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The DepEd Schools Division Sorsogon now invites bids for CY 2024 BEFF- Repair and Rehabilitation of School Buildings Completion of the Works required per school is indicated on the table above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Bid opening shall be on *December 09, 2024, 09:00 a.m* at *Conference Room, DepEd SDO Sorsogon, Balogo Sports Complex, Barangay Balogo, Sorsogon City.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Please take notice that the Bids and Awards Committee shall mandatorily require a *Special Power of Attorney* to representatives who shall join/attend the bid opening, to effectuate special and limited purpose(s) such as to bid, contract or negotiate for the purchase, or all other actions necessary to participate, in the best interest of the procuring entity. Late bids shall not be accepted.

- 8. **DepEd SDO Sorsogon Province** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
